In order to host or curate an individual/dual artist or group show at the Beyond Gallery located at 437 Main St. in Bennington, VT, please send the following to [info@thebeyondgallery.com](mailto:info@thebeyondgallery.com):

1. Artist Statement specific to the show you wish to exhibit.
  - a. Will there be a theme?
  - b. Or will it be a general collection of works?
2. How many artists will be included?
3. How many pieces do you expect to have on display?
4. Are the works new creations or previously exhibited?
  - a. If previously exhibited, please advise to the date and location they were on display.
5. Are there specific show dates you are applying for?
  - a. Is there a time of year or time frame you prefer?
  - b. Please keep in mind that we schedule shows at least a year in advance.
6. Have you read and agree with both the “Artist(s) or Group Show Hold Agreement” and the “Gallery Consignment Agreement”?
7. It is imperative that your show be able to fill our gallery space. Floor plans are available for planning purposes. Please request these prior to submitting your application.
8. Please include 5-10 images of your work. These do not need to be images of the pieces you intend to use for the show, but must be able to properly show your style and quality of work that will be expected for your show.
9. Any additional statements, resumes, references you wish to include are welcomed but not required.

The Artist(s)/Group written above and the Gallery, The Beyond Gallery & Gift Shop, hereby enter into the following Agreement:

1. The purpose of this agreement is to hold specific show dates for artists or groups to curate their own show at The Beyond Gallery located at 437 Main St. in Bennington, VT.
2. It is agreed by both parties that the "Show Dates" listed above represent the first and last day of the exhibition period.
3. The gallery space will be available for exhibition set up beginning on \_\_\_\_\_ after 4pm and every day following at 4pm until the show opening. Should the Artist(s)/Group need the space before 4pm on any given day, the Gallery will work to accommodate this request.
4. All work must be taken down and removed by 10pm on \_\_\_\_\_ and the gallery must be returned to its original condition.
5. Should the Artist(s)/Group or the Gallery need to cancel this agreement, they must do so in writing 90 days prior to first day of the exhibition period. Any cancellation by either party after 90 days will result in a \$150 fine to be owed to the other party within 14 days of the cancellation.
6. Please refer to the Standard Gallery Consignment Agreement for all other conditions to be applied during the exhibition period.
